The State of Missouri Department of Economic Development has recognized the Discovery Center of Springfield (DCS) as a highly capable, qualified non-profit focusing efforts on awareness, education, and reduction of opioid misuse with a \$473,787 award in State of Missouri NAP tax credits to deliver a STEM and opioid education program to 10,500 underserved individuals right here in the Ozarks through 2021.

Businesses can donate cash, materials, supplies, or equipment; technical assistance and professional services; labor; real estate; or stocks and bonds. Credits can equal up to 50 percent of the total amount contributed.

Eligible donors include:

- Members of an LLC
- Shareholders in an S-corporation
- Partners in a partnership
- Sole proprietorship operators
- Individuals with rental property or royalty income
- Farm operators

* Federal tax savings assumes 24% tax bracket, donor is itemizing deductions, and the contribution deduction is reduced by the amount of tax credit the donor receives consistent with Proposed Regulations issued in August, 2018

** Assumes 6% rate deduction is reduced by the amount of tax credit as described

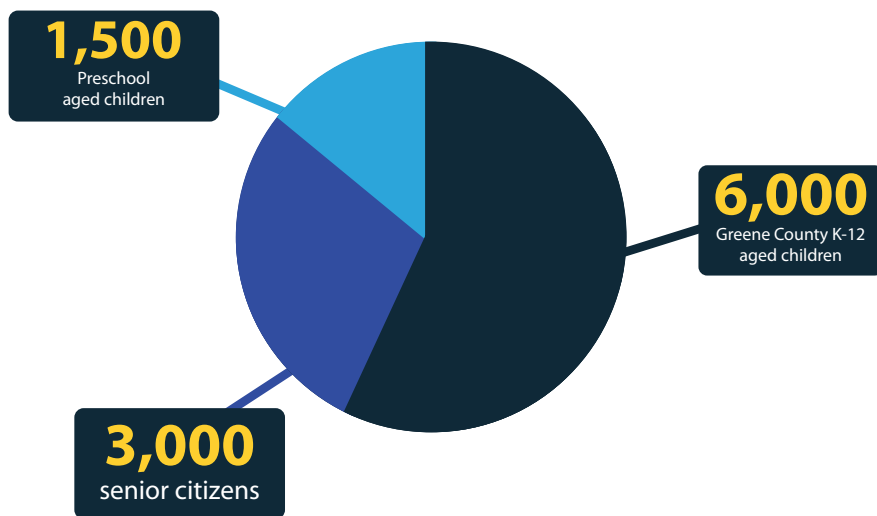
